Preamble: Aims and Structure of the Health and Social Services Degree Program at the University of Applied Sciences Nordhausen

The aim of the Bachelor's degree course is the professional qualification as a state-recognized social worker / social pedagogue with special consideration of the field of healthcare (in accordance with Section 1 of the Thuringian Law on the Recognition of Social Pedagogical Professions (ThürSozAnerkG)). This requires a generalist training in the field of social work and further specific scientific and practical knowledge in the health sector for health promotion, prevention, psychosocial support, social space orientation and counseling of people with health and / or economic problems.

The Health and Social Services degree program is based on current social transformation processes and the associated changes with regard to professional advice, care and support before and after health and social problems arise. Health and Social services are closely intertwined. Therefore, there is a high demand for professionalism, which can be developed through a scientifically sound, practice-oriented and interdisciplinary study of social work.

Due to international developments driven by the WHO (e.g. the International Classification of Functioning / Disability and Health / International Classification of Functioning ICF 2005 and the World Health Organization WHO 2017), it is clear that responsibility for health and healthcare will no longer be shaped by just a few professional groups in the future, but will be assumed by different professions according to needs.

The background to this is, in particular, the onset of demographic change in terms of the structure of services and target groups, the preference for outpatient over inpatient services in the areas of child, youth and elderly care, health care and the strengthening of preventative and regional or social area-oriented measures. Health impairments are often closely linked to social problems and individual lifestyles. Accordingly, in addition to coping with illness, the focus of the degree course in Health and Social Services is on resource and competence-promoting specialist knowledge as professional personal social services.

In view of demographic change, structural change, the internationalization of the labour market and economic development, there is a glaring shortage of skilled workers in Germany. This is also noticeable in social work, particularly in the area of child and youth welfare. Due to the requirement for skilled workers in social work (Section 72 SGB VIII), it is urgently necessary to train sufficient employable, professional junior staff for this and other areas.

In accordance with the Qualifications Framework for German Higher Education Qualifications (resolution of the Standing Conference of the Ministers of Education and Cultural Affairs of 16.02.2017), the degree program aims to achieve a broad and integrated knowledge and understanding of the scientific foundations of social work in the healthcare sector in line with the current

state of specialist literature and including in-depth knowledge based on the current state of research. The concept of the degree program takes into account the level definition for social work specified by the QR SozArb 6.0 for Germany and in compatibility with European and non-European frameworks. These references are specifically identified for each module in the module handbook of the degree program.

In subject-specific terms, the HSN's range of courses is significantly shaped by this qualifications framework for social work. With the voluntary European Qualifications Framework (EQF) and the entry into force of the now binding German Qualifications Framework (DQR) in 2013, a common framework was established for higher education and vocational education and training. The qualifications framework for an individual subject is intended in particular as an orientation framework.

The general requirements profile for graduates in QRSozArb 6.0 is specified in the individual module descriptions via the formulated qualification objectives. For the Health and Social Services degree program, a differentiation between Bachelor's and Master's level was taken into account, which is referred to in the Qualifications Framework for German Higher Education Qualifications (HQR). This provides taxonomy tools to differentiate between the levels. The differences in level between Bachelor's and Master's have been incorporated into the new module design.

The general educational goal of social work is to develop the professional competence to play a supporting role in shaping social, psychological, physical and cultural life situations. Particular emphasis is placed on the ability to continuously transfer scientific knowledge to practical implementation (evidence-based competence) on the one hand, and on personal skills such as the ability to deal with criticism, crisis and conflict on the other. To achieve these goals, the importance of life-long learning is conveyed as an important study objective.

The course comprises seven semesters (standard period of study), in which, in accordance with the requirements for state recognition, a practical work placement lasting a total of 100 days is integrated. This practical phase is planned for the fifth semester. The aim is to achieve a professional qualification in the sense of basic professional skills with the ability to independently master new fields of activity.

In addition to the predominantly generalist orientation of the degree program, the elective specializations and the compulsory elective area allow students to focus the course content according to their interests.

The following is an overview of the degree course. A detailed curriculum is attached to the study regulations and can be found on the homepage of the University of Applied Sciences.

- O1-1) Students name the organizational forms of the various social work providers; they differentiate between work tasks, professional field, institutions, organizational forms and addressee-related social work services. They define social work, question its image of humanity and develop a professional attitude towards the recipients of social work that appreciates diversity.
- O1-2) Students develop an understanding approach to different living environments and minorities along the various dimensions of diversity. Students are able to differentiate between prejudices and stereotypes and know why people need them. They question their own prejudices and reflect on their own attitudes in order to develop initial professional perspectives for action. In service-learning, students combine academic learning with civic engagement in the form of a service for non-profit organizations. They make a useful contribution to improving social tasks and analyze civic engagement.

- 02-1) Students know and understand the history and development of social work and social pedagogy into the profession and discipline of social work. They know important personalities in social work. They will be able to place their work in the context of historical, social and professional developments.
- 02-2) Students can independently develop and discuss basic concepts by analyzing specialist literature. They can develop their own technical theses, substantiate them with arguments and discuss them. They formulate feedback and professional criticism and integrate the feedback they receive into their work process.

Students understand risk and protective factors, social triggers and consequences of health and illness. Students are familiar with various health science concepts and settings.
