#### 1. Learning outcomes

Students will understand the economic and legal background of legal transactions and be able to evaluate these with respect to their validity. They will also be able to test the contestability of declarations of intent. Students will be informed about the statute of limitations and know the essentials of the law on breach of performance. They will be familiar with the main provisions pertaining to purchasing rights between private individuals, and with commercial transactions. Students will be able to explain the concept of the status of a merchant, the different forms of merchant and the functions of the commercial register. They will be familiar with the positions of self-employed and employed traders' assistants. They will understand the effect of an entry in the commercial register by the legal representative of a company and its removal. Students will be capable to identify simple problems from the legal areas listed and will be able to solve these using the subsumption technique.
