1. Learning outcomes

Students will be familiar with the key principles of corporate enterprise law, partnership law, as well as corporate group law, with a particular focus on corporate enterprises. They will have an overview of the typical problem areas in companies and be capable of initiating measures related to corporate law. Students will be able to evaluate the economic activities of the public authorities, and apply conditions of legitimacy to specific cases. They will be able to evaluate the different legal and organisational forms of municipal businesses from the perspective of legal and business management perspectives, and to implement their legal basis. They will be able to make decisions about the formation of a company and explain their reasoning. They will be able to organise the management of municipal subsidiaries and create annual reports. They will be cooperative and show social responsibility when working together with others. They will be able to express their arguments clearly and solve conflicts constructively and in an open-minded manner.
